IMPORTANT REMINDERS

- YOU'LL WANT TO MAKE NOTE OF:
 - USERNAMES/PASSWORDS ASSOCIATED WITH YOUR SPECIFIC ACCOUNT.
 - SECURITY QUESTIONS AND ANSWERS.
- ALL APPLICANTS ARE REQUIRED TO HAVE A STUDENTAID.GOV ACCOUNT OR CADAA ACCOUNT.
 - IF THIS IS YOUR FIRST TIME FILING, WE CAN GUIDE YOU WITH YOUR ACCOUNT CREATION.

2022 TAX INFORMATION

- FOR FAFSA FILERS: THE FAFSA HAS A NEW DIRECT DATA EXCHANGE REQUIREMENT WHERE THEY WILL AUTOMATICALLY OBTAIN FEDERAL TAX INFORMATION FROM THE IRS WHEN YOU PROVIDE CONSENT AND APPROVAL. THUS, MOST STUDENTS DO NOT NEED TO BRING THEIR PHYSICAL 2022 TAX RETURNS.
 - SOME APPLICANTS MAY HAVE UNIQUE CASES WHERE THE PHYSICAL 2022 TAXES WILL BE NECESSARY.
- FOR CADAA FILERS: THE CADAA REQUIRES YOU TO MANUALLY INPUT YOUR 2022 TAX INFORMATION.
 - PLEASE BRING YOUR 2022 TAX RETURNS AS APPLICABLE.
