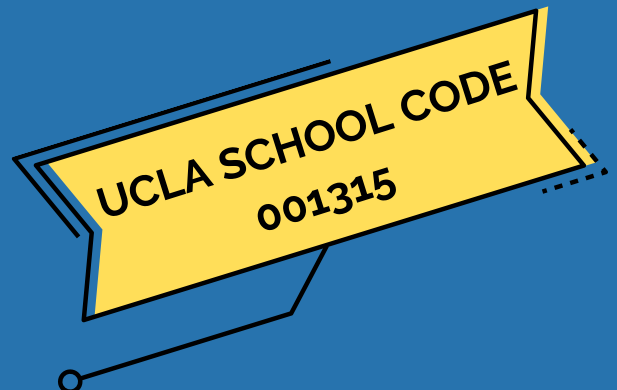

TO-DO LIST IN PREPARATION FOR A WORKSHOP OR COMPLETING YOUR 25-26 AID APPLICATION:

FAFSA Filers

- Create/Access your FSA ID and make sure you can log in via www.studentaid.gov.
- Confirm your contributor (if applicable) has an FSA ID and can log in as well.
- Have your contributors information available to invite them to complete their section. It must match their account information in order for the invite to be sent.
 - Full Name, Email and Social Security Number (SSN)

NOTE: Students with a contributor that does not have an SSN will need to mark that their contributor does not have an SSN and input their mailing address as listed on their contributors account.

- Have all 2023 Tax information readily available in case additional information is requested beyond the Direct Data Exchange tool.

NOTE: All students and contributors are required to give "Consent and Approval" in order for a Direct Data Exchange to occur. This will allow Federal Student Aid to retrieve your 2023 tax information directly from the IRS.

Student's who do not give "Consent and Approval" will be able to submit their application, but not be eligible for financial aid.

CADAA Filers

- Create/Access your CA Dream Act account credentials and make sure you can log in via www.csac.ca.gov.
- If you are renewing your CADAA, confirm your contributor (if applicable) has their 4 digit pin so they can sign your application once you have submitted it.
- For new filers: After completing your online application, your contributor will navigate to the link that says "Submit Parent Signature." Your contributor will be able to create a 4-digit electronic PIN code to sign your application. Please keep record of this pin as it will be used every year you apply.
- Have all 2023 Tax information readily available to complete your application.
