

UCLA Financial Aid Disbursement Schedule 2025-26

Updated December 3, 2025

The term *disbursement* is used to describe the process of transmitting student aid funding (including student loans) within the Bruin Financial Aid System to UCLA Student Accounts division for processing and posting to a students' UCLA BruinBill. Disbursement dates are determined by federal regulations and UCLA policies.

A <u>disbursement</u> is different than a <u>refund</u>. Student aid funding <u>disbursements</u> (including student loans) are managed by UCLA Financial Aid & Scholarships, whereas financial aid <u>refunds</u> are managed by UCLA Student Accounts. UCLA Student Accounts provides a helpful <u>Student Billing Calendar</u> online.

Disbursement transactions begin for the term or month on the <u>evening</u> of dates indicated below. Any student aid funding awarded after the indicated commencement date will disburse each night thereafter, except on weekends and University holidays.

<u>Students may view credits to their account on their BruinBill the following morning AFTER disbursement commencement date.</u> Disbursements are applied to unpaid charges before becoming eligible for refund. Unapplied credits are then processed for refund based on a student's enrolled refund method.

Students are highly encouraged to enroll in <u>BruinDirect</u> as this refund method will deposit funds to their enrolled bank account as early as 2-3 business days after disbursement date during regular academic year terms. The provided <u>BruinDirect</u> link also provides refund payment options for international students that may not have a U.S. based bank.

<u>BruinDirect</u> refunds are initiated each business day for regular session terms, whereas refunds initiate each Friday for Summer Sessions. Those not signed up for <u>BruinDirect</u> will be mailed a paper check produced on a weekly basis and relies on the accuracy of address information provided to UCLA.

Prior year aid disbursements, 2024-25, will continue to be processed nightly (except weekends and University holidays).
